Prize money will be awarded in this event. The entries in this event are limited, and only sixteen players will be entered directly into the main draw. All other players accepted into the event will be required to play qualifying rounds on Tuesday, April 24, 2018, at the Ojai Valley Athletic Club. Players may play both singles and doubles in the open event, but may not enter any other event. Your entry must be mailed to: OVTC, P.O. Box 482, Ojai, CA 93024, by April 14, 2018. Each entry must enclose a photocopy of your USTA card (which must be current through the entire tournament period). There will be an additional charge of \$25.00 for late entries, if accepted, or for late payment of fees. Players should register at the site of their first match at least 15 minutes prior to scheduled match times. Times and locations of matches will be available on the tournament website, www.ojaitourney.org, by Monday noon of tournament week. No players passes will be issued, so your USTA card or other ID will be required to gain free entry to sites where spectator admission is charged. Coaching is not allowed. In addition to winner and runner-up awards, the All Comers Challenge Cup will be awarded in the Men's Open Singles Championships.
